As per the Fund's January 31, 2025 Prospectus, the total annual Fund operating expenses as a percentage of the value of your investment, which incorporates indirect fees and expenses that the Fund incurs from investing in the shares of other mutual funds including money markets, otherwise known as Acquired Fund Fee Expenses or AFFE was 0.96%. Provident has contractually agreed to cap the ratio of expenses to average net assets at 1.00% through January 31, 2026.
